RE: Louisiana eProcurement Solutions by Ariba (LESA) – Agency Implementation Schedule

As part of the Office of State Procurement's continued efforts to improve the Request for Proposal (RFP) process, OSP is onboarding State agencies in LESA according to the attached phased implementation plan.

Agency onboarding will occur in six waves with the first wave beginning February 1, 2021. Each agency's onboarding is expected to last three weeks. The initial two weeks is devoted to implementation which includes a walkthrough of LESA and capturing data to be entered. The data captured will include active contracts, upcoming RFPs, and agency users and roles. The last week will be devoted to in-depth training on LESA processes, how to write the Scope of Work, and how to develop proposer questionnaires.

Approximately one month before each agency is onboarded, OSP will contact the agency to obtain the appropriate contacts and begin scheduling meetings.
